Before jumping to the obvious conclusions that:


- 1) this is just another mob of rejected, scorned women; and



Why does Facebook refuse to allow the voices of victims like myself be heard?

Although I first diligently tried to join these Facebook AWDTSG groups to defend myself against the accusations of these Facebook AWDTSG losers, Facebook and its AWDTSG groups, their creators, admins and mods refused to allow me to join any of its AWDTSG forums.

On Facebook you and everyone you love can be cyber-stalked, cyberbullied and defamed to millions of Facebook viewers in Facebook groups while you and your loved ones will never be allowed to join these Facebook groups to defend your good names and reputations.

Since Facebook and its AWDTSG groups maliciously offer no remedy, I then was forced to contact the LAPD and FBI and file the above-noted lawsuits. This means that **Facebook is itself an anonymous criminal organization, in particular...**

Although reddit.com is in essence no different than any other mainstream military surveillance front, a few people there are waking up to the fact that Facebook and its AWDTSG forums extort money from its silent victims. This means that Facebook and its AWDTSG forums function exactly like previous revenge-porn platforms. What is a revenge-porn platform?

Meet Cheaterreport.com

As I have also made clear in previous court documents, my girlfriend and I were anonymously stalked, harassed and cyberbullied on the

revenge-porn website Cheaterreport.com ("Cheaterreport") from 2016 through 2018.

Worse, we were also extorted by Cheaterreport. We had to pay thousands of dollars to various anonymous "third-parties". Later, I discovered these to be, in part, an individual named Domingo Rivera: a navy-cyber-security governmental employee with highest level security clearance who lives in Virginia walking distance from each of the headquarters of all 18 "intelligence" agencies. Rivera works closely with another loser Aaron Minc who lives in Ohio in the heart of Rockefeller/Rothschild mafia.

This is the scum with whom Sherrie and I had to "interact" and to whom we had to pay money to remove harmful, anonymous postings on Cheaterreport. This is when we needed this money to fight the cancer to which she succumbed in 2018.

But the judge in this case (LASC case no. 19SMCV00935) unlawfully denied compelling my lawful subpoena. She wrongfully claimed that forcing Facebook to give up the identity of Cheaterreport would violate the "privacy" of Cheaterreport. Because it remained unclear whether Cheaterreport was a person or a business, the logic



of judge, even within our currently corrupted legal landscape, made no sense. Businesses cannot claim privacy. Nevertheless, we have to ask:

Why is the revenge-porn terrorist app Facebook along with its AWDTSG forums not prosecuted?

In a way, I suppose I have already answered this question. But I invite everyone to contact any and all city and/or county and/or state district attorneys' offices. Ask them why they are allowing criminal military fronts like Facebook and they AWDTSG forums to experiment on us? If you can try and/or actually vote any of said "attorneys" who fail to act lawfully out of office, that would also be an effective way of applying pressure.
